THE PROBLEM

You can't aggregate what you can't verify.

Digital-asset exposure sits across multiple external managers, each reporting in its own format, on its own schedule. Aggregate risk is assembled by hand, after the fact, and rests on trusting what each manager reports.

- No single view of exposure across managers and mandates.
- Reporting arrives in different formats, at different times, reconciled by hand.
- Aggregate risk depends on manager assertions you cannot independently check.

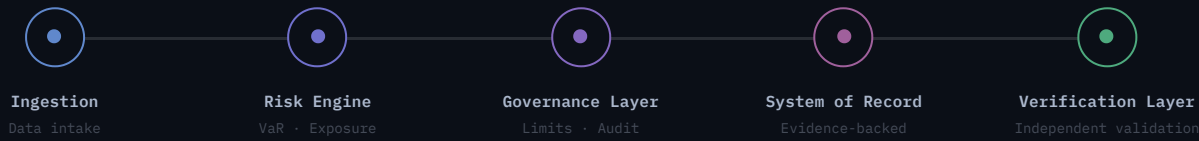
WHAT YOU GET

- One consolidated view of digital-asset exposure across every manager and mandate.
- Exposure you can verify against evidence, not accept on trust.
- Aggregate risk oversight, without standing up a risk-infrastructure team.

WHAT IT IS

- Consolidates positions across venues into a single risk state.
- Enforces limits and produces IC-ready decisions.
- Generates evidence-backed, audit-verifiable reports.

ARCHITECTURE

| 01 | Ingestion | Consolidates positions across venues and custodians into a single, normalised risk state. |
| 02 | Risk Engine | Computes exposure, leverage, value-at-risk, liquidity and scenario stress across the consolidated book. |
| 03 | Governance Layer | Enforces mandate limits and surfaces breaches into IC-ready decisions. |
| 04 | System of Record | Records every risk-state transition as the fund's authoritative reference. |
| 05 | Verification Layer | Produces evidence bundles that can be verified independently of the platform. |

OPERATING CYCLE

Reports are generated directly from system state. Every step is recorded and auditable.

08:00**Data ingestion**

Exchange, on-chain and custodian data ingested.

08:05**Risk snapshot**

VaR, leverage, exposure and liquidity calculated.

08:10**Limit evaluation**

All limits evaluated. Breaches flagged.

08:15**Alerts & incidents**

Escalations recorded to the audit trail.

08:30**IC Pack generated**

Investment Committee report produced from ledger state and distributed to authorised stakeholders.

SAMPLE OUTPUT • IC PACK

The deliverable. Every snapshot renders an Investment Committee report from verified risk state. The pages that follow are an actual, illustrative example. This is an example of the risk report you would see for a single holding.

ILLUSTRATIVE HEADLINE METRIC



Venue concentration at 82% against a 60% mandate, 22pp over limit. This is the breach the report flags. Illustrative sample.

A single page carries the decision: the top-level call, the quantified downside, the specific mandate breach, and the action to take, each traceable to the underlying risk state.

WHAT TO LOOK FOR

- 01 Top-level IC decision:** CRITICAL, with the reason stated in one line.
- 02 Quantified downside:** estimated 11.6–46.5% NAV drawdown under stress.
- 03 Specific breach:** venue exposure 82% against a 60% mandate.
- 04 Recommended action:** reduce venue exposure ~22% immediately.

PORTFOLIO STRUCTURE & RISK

EXPOSURE STRUCTURE

CONCENTRATION

Venue exposure of 82% exceeds the 60% mandate, drives concentrated operational dependency on a single execution venue.

STRUCTURE

Execution concentrated on Binance at 82% of gross exposure (mandate: 60%), results in settlement and operational dependency on a single venue.

DOWNSIDE

Under a 5–20% adverse move at Binance (\$7.0M gross exposure), expected NAV drawdown is **11.6–46.5%**; venue disruption eliminates all execution optionality on affected positions.

EXPOSURE DETAIL

Top-3 exposure: 167% of NAV (limit: No mandate limit defined.%).

Primary instruments: BTC-PERP, ETH-PERP, SOL-PERP.

Primary venue: Binance.

Gross exposure: \$8,500,000 (283% of NAV).

INTEGRITY LAYER

Enables independent verification of reported risk state.

Immutable Audit Trail

All risk-state transitions recorded in an append-only ledger.

Independent Verification

Evidence bundles on every report output, independently reviewable without infrastructure dependency.

Deterministic Replay

Full audit replay from event log to any historical state, producing consistent results.

BOUNDARIES

What Keystone does and what it deliberately does not.

- Read-only** Keystone observes and reports. It does not place, modify or route orders.
- No custody** It never holds assets, keys or client funds. Positions are read, never controlled.
- Decisions, not execution** It produces IC decisions and recommendations; acting on them stays with the fund.
- Institutional only** No retail availability. Access is limited to institutional counterparties.

DATA & SECURITY

How data is handled, where it lives, and who can reach it.

Data residency

All data is processed and stored within the European Union, on established cloud infrastructure.

Encryption

Encrypted in transit (TLS) and at rest (AES-256), across compute and storage.

Access control

Role-based access: administrator, viewer, and auditor roles, over authenticated sessions.

Audit & evidence

Risk-state transitions are recorded in an append-only audit trail, with evidence bundles attached to report outputs.

Read-only connectivity

Venue and custodian connections use read-only API credentials. Keystone never requests withdrawal, transfer, or trading permissions.

Credential handling

Connection credentials are encrypted at rest and held in a dedicated secrets vault, never in source code.

Infrastructure security

Administrative access is protected with two-factor authentication; deployments use federated identity with no long-lived keys.

Data footprint

All application data resides in a single encrypted EU datastore. No third-party object storage.

- **All data processing occurs within the European Union.** No client assets, keys, or funds are ever held.
